Continued work on the club's first operating budget has ensued over the last month and I look forward to the board discussing at the next meeting what has been put together. Special thanks to Mike Clemens, Vice President, for assisting Mike Harrington, Treasurer, to kick start this new development for the club. And, to the board members who have offered input. The goal for the budget was to define the club's anticipated expenses and reserve needs and determine a dues structure that would support that and to relieve. In addition, having the budget will relieve board action to approve every expenditure regardless of size.

The date of the joint dedication ceremony for donor recognition and naming of the Kent J. Blumenthal Pickleball Complex will be held on Wednesday, December 2, 2020 at 2 p.m. Invitations and RSVP instructions will be forthcoming. Final work on the donor recognition structure is occurring with Tim Stewart's excellent work in both the design, artistic components and working with the various vendors that will be involved. Tim, Dean Olson, and I met in mid-October to map out the donor name plates and it is going to be a visually stunning piece.

The new shade structure at the PBC has been erected and it is a beautiful addition and will provide much needed shielding from the sun for those using nearby courts. There was a lot of work done by Mike Clemens behind the scenes with GVR and the contractor which made this possible. Mike's engineering background was a perfect fit to be in charge of this project and my gratitude cannot be overexpressed. I hope club members will agree and join with me in a hearty thank you to him for his service in this regard!

Users of the Pickleball.Plus court reservations and event calendaring have made the transition with just a handful needing some assistance in navigating it. Dean Beilke has been his usual stalwart presence to make it happen. Thank you, Dean!

The Pickleball.Plus online membership application function is working well. The intent was to provide **new** members a way to have their application processed immediately and reduce the time board volunteers spent manually processing. Members wishing to renew their membership will be able to do so beginning January 1, 2021. Special thanks to Mike Harrington and Susan MacMillan for digging deep to learn the new aspects of this system and assisting our members.

The Ratings Review Prep Pilot Program survey was completed by over 60 members with half expressing interest in testing up and the other half volunteering to help. After the first session, it was determined that the structure did not meet the objectives set forth as not all respondents were truly interested in testing up, but wanted to see what the program was about and were looking for instruction. It will be replaced with the development of a "Call List" of players willing to participate in arranged games with members wanting to test up (the member wishing to test up will be responsible to contact players to arrange games). Those seeking instruction are encouraged to take advantage of the club's educational offerings such as SNAP, PB201 and PB301. Special thanks to Kathy Palese for conceiving of the idea and Suzanne Nordhagen and Carol Hammerle for assessing how to move forward.

Carol Hammerle and I met with GVR to discuss the status of allowing guests as it relates to league play (TAPPL) for our home matches to commence in January 2021. No decision has been made as of this writing. If no guests are allowed, other options are being considered for GVR's home courts at an alternate location.

GVR is in a transitory state as it relates to the hiring of a new CEO. Coupled with this and the fallout of the COVID-19 issues, the current staff has experienced many changes and challenges which has adversely affected how certain club issues have been handled recently. In my report last month, I indicated discussion was ensuing with GVR as it relates to how the club and/or GVR can enforce adherence to club policies and what a prudent path would be. At this point there are two paradigms for clubs, dedicated space and non-dedicated space. The pickleball club is considered a non-dedicated space and there is not a compelling rationale to change this given the current criteria. Discussion with GVR this week revealed changes are being made with certain staff roles, responsibilities, and authority that we hope will address the concerns we have experienced.
