6. Old Business

a. Financial Planning Committee Member Survey

The Financial Planning Committee conducted a survey of members, managed by Janet Reynolds, to determine member preferences for future capital projects. Key results from the survey:

A. 252 respondents out of 1032 surveys sent out. A 24% response rate (10-33 % response rate considered reliable)

B. Most Preferred project:

PBC (1) - 67

Canoa (2-5) - 121

188/252 (75%) - preferred adding courts at PBC or Canoa

C. Least preferred Project:

no additional courts - 189/252 (75%)

D. Willingness to donate:

only after GVR approves any project - 68% will not donate - 12%

- E. More likely to donate if donation is matched 70%
- F. Respondents who live in GV or moved here because of PB facilities $40\%\,$

The preferred project (more courts at Canoa Ranch) was submitted to GVR as a capital request to be funded by the club.

The board approved submission of the capital request by unanimous consent.

b. GVR Type II Capital Request

The Type II Capital Request submitted to GVR approved via unanimous consent of the Board of Directors will be presented. The capital request is based upon the recommendation of the Financial Planning Committee and supported by the recent member survey regarding possible enhancements to the pickleball facilities.

BDM Ventures LLC DBA as Mr. & Ms Pickleball, will become the sole supplier of pickleball apparel, shirts, jackets, hats or visors, with the GVR Pickleball Club logo. Mr. & Ms Pickleball will display samples of apparel to be sized, customized and personalized, using the GVR Pickleball Club logo at the Green Valley Market on Wednesdays from 9 - Noon October - March at their booth. The apparel will consist of high-quality material and will be professionally printed.

The turnaround time of orders placed, and delivery shall be seven business days on standard orders, and fourteen days on custom orders. There is a no return policy on orders. Apparel will be priced at fair market prices. Any shipping charges will be the responsibility of the buyer.

In order to sell on the pickleball courts, the supplier is required to complete and obtain approval from GVR of the Temporary Display Request and will be at the invitation of the GVR Pickleball Club.

Mr. & Ms Pickleball agrees to compensate the GVR Pickleball Club with a sum of \$2.00 per shirt or jacket and \$1.00 per hat or visor. This payment will be calculated at the end of each month and a check issued to the GVR Pickleball Club within seven business days.

This contract will be effective November 1, 2024.

This agreement may be terminated by either party with 30 days written notice.

Carol Hammerle - 2023-24 Summary GVR Pickleball Player Development:

34 GVR Pickleball class were offered 12 PB 101 classes which includes April With few exceptions PB 101 had 24 participants

Other classes were PB 201, 202, and PB 301, Pickleball MLP by SNAP, Pickleball Mindset of Winner by SNAP

GVR Class Attendance:

Pball 101: 244 Pball 201: 64 Pball 202: 47 Pball 301: 27 MLP: 36 SNAP: 83

Developing Skills is a program offered to GVR Pickleball Club members or non-members trying the sport out for the first time. Players are allowed to attend 4 times without a club membership. During the fall and winter months classes are offered Tuesday/Thursday from 1:00-2:30 PM. Developing Skills is primarily to help 2.00 players become 2.5 .

From September 2023 -March 2024 190 players were involved with the program. 56 players tested up to 2.5 Jane Hunt is the coordinator of fall and winter program.

Summer program starts May 7, Tuesday and will run through to Tuesday, October 1, 2024. Peter Fronsee coordinates the summer program.

Player Development Program starts in June 2024 -October 1, 2024. All programs are offered in the morning from 7:00 am-10:00 AM. Marilyn Rambo organizes and coordinates the 2.5-3.0 skill level, Greg Wright coordinates the 3.0-3.5 program and I take care of the 3.5-4.0 program. Last year the 3.0 program required 6 courts the majority of the summer so stations were utilized to meet the demand. The program has been well received so plans are to continue this summer.

Byrd Penney Clinic in January 2024 was a huge success. We offered 4 sessions with 16 players in each session from Monday -Thursday. Everyone's feedback was positive so plans are to bring Byrd back next January 2025. to do a Pro Volley technique clinic.

SRAPPL-Southern Region Arizona Pickleball Players League-There were 2 women's teams competing in SRAPPL this year. A 3.0 women's team, Blazing Paddles and 4.0 women's team, Drop Squad. Both teams were quite successful qualifying for Regional play at Udall Park in Tucson. Winners of the Regional will advance to State Tournament at El Mirage, with the winner of State advancing to Nationals in Hilton Head, South Carolina. I want to thank all the players who helped scrimmage the women's 4.0 team every Friday. They were the reason for our success as a team. Brad Dubuc, Wally Rhodes, Paul Osika, Steve Fernandez, Dave Hendrickson, Dave Maier, Mike Mai, Tess Campfield, Al Skoglund, Shirley Schaller, Kathy Palese, Susan T and Dan Petree.

Steve Reynolds - 4.0 Advanced Play Committee

Here's a summary of the Advanced Play Committee's mission & its new programming this season. A motion to form the committee below was passed at the November 9, 2023 board meeting.

Motion: "To form an advanced play committee with the goal of establishing new programming for advanced 4.0 players. The new programming will be offered to 4.0/4.5 players who qualify to play through a selection process to be determined."

57 of the 137 4.0/4.5 club members have qualified to play in this group. Not all players are active, but we've had good turnout for the M-W-TH-S programming sessions.

Mission of the Advanced Play Committee:

- 1) Create advanced play programming including but not limited to: Mens/Womens and Mixed Shuffles, Round Robins, Challenge Courts, Skills & Drills, Ladder and DUPR. Monday- Men's shuffle/round robin/qualifier, Wednesday mixed drills, Thursday women's shuffle/round robin/qualifier, Saturday Mixed doubles round robin.
- 2) Create a qualification process for advanced play programming for men and women through separate round robins requiring players to score 45 points in 5 games. 4.5 players automatically qualify.
- 3) Promote court allocation of the 8 courts between 4.0 programming and advanced play programming during prime time play.
- 4) Create a path from a 4.0 to 4.5 Rating for the 4.0 advanced players through DUPR and/or IPTPA.
