- c. Reserve Fund Subcommittee: I make a motion to form a reserve account subcommittee consisting of the club's treasurer as committee chairperson and other club members. The role of the reserve committee is to set guidelines for the transfer of money in and out of the reserve fund and make recommendations to the Club's Board of Directors for court and club future improvements. No money in the reserve fund would be spent without approval of the Board of Directors. (Mike Clemens)
- d. **Policy Manual Updates** Motion to approve the updates to the Club Policy Manual regarding Skill Level Play (formally Focus Play) & Mixed Skill Level Play, and removing Gold/Silver queuing based upon prior Board approval. (Paul May)

GVRPC Policy Manual - Updated August, 2021: Posted on the GVRPC Club Website

. Court rules

i. Paddle queueing is used as a method to determine which group of players is to use the next available court and is directed by the Court Management Committee and Court Coordinators.

ii. During Focus Play Skill Level Play: Paddles may be grouped by two players to allow practice together with a partner with minimal disruption to the flow of players to the courts.

iii. During Drop-In Play: Paddles may be grouped up to four players.

iv. During heavy court usage: The Gold/Silver queueing process may be implemented when there are 20 or more paddles in a queue. Court Coordinators may implement a "win by one" or play to nine points format to speed play.

c. Focus Play Skill Level Play (SLP) & Mixed Skill Level Play (MSLP)

- 1. Court schedules are intended to provide equal time for each focus group daily, if possible. GVRPC requests that club members honor these designated times and particularly during the high season of September April. Skill Level Play (SLP): An opportunity to play with players at the same skill rating. It is open to Club members at the designated skill rating and GVR members & GVR guests, who demonstrate requisite skill level play. Level designations shall be observed during Skill Level Play and organized/formal Round Robins. Usually uses paddle queuing to determine who plays next. No prior sign up is required. In effect, October 1st through May 31st.
- ii. Mixed Skill Level Play (MSLP): Opportunity to play with players at the same skill rating plus players 1 skill level lower & 1 skill level higher, creating mixed skill level play. The specific mixed skill levels for:
  - 1. 2.0/2.5 includes 2.0/2.5 & 3.0
  - 2. 3.0 includes 2.0/2.5 & 3.5
  - 3. 3.5 includes 3.0 & 4.0
  - 4. 4.0 includes 3.5 & 4.0

It is open to Club members, GVR members & GVR guests and uses paddle queuig to determine who plays next. No prior sign up is required. In effect, June 1 through September 30.

ii iii. The Gold/Silver queuing system is recommended during this high season in designated Focus Skill Level Play times. This system moves the winning pair from each game to the Gold queue and the losing pair to the Silver queue. Within a club skill level group, there are stronger and weaker players, and the intent of this system is to provide a more balanced group within each queue. Other skill level groups are encouraged to adopt this system to see if it is advantageous for their group.

iii. Court monitors may educate members on the queueing systems, court schedules, and club policies. GVR has stated that the club may not request that those members playing during focus skill level play outside of their club rating be asked to leave. Court monitors may only suggest that members play during the designated days and times for their club rating.

e. **Member Agreement** - Motion to approve the below Member Agreement which new and renewing members must agree to either online or as part of the member application. (Mike McCarry)

Member Agreement

The purpose of the GVR Pickleball Club is to provide a safe, fun, and enjoyable environment for its members. This implies sportsmanship, respect, and proper court etiquette towards fellow Club members, guests, and GVR personnel. The Club will respect the needs and goals of all players

endeavoring to provide events and play to meet all player needs.

This agreement may be revised from time to time. Each member is responsible for knowing the contents of the Membership Agreement and agrees to abide by its content.

#### Code of Conduct

- · I will comply with the GVR Pickleball Club Policies and By-Laws.
- · I will comply with posted court signage and schedules.
- · I will adhere to the USAPA pickleball rules.
- · I will make fair line calls and respect calls made by others.
- · I will not act or play in a way that maliciously threatens my safety or the safety of others.
- · I will refrain from verbal outbursts which are profane, threatening or abusive.
- · I will respect GVR Recreation property and perform no actions which may cause damage.
- · I will comply with the GVR Recreation applicable rules & policies.
- · I will do my best to present a positive image to the local community as a representative of the GVR Pickleball Club.

## **Networking with Members**

I understand that when I join the GVR Pickleball club, personal information is entered in the Club Member Directory (Pickleball Plus) which is available on a members-only password-protected page for networking with other members. I will not download, republish or duplicate the information in the Member Directory — in whole or in part — for commercial or any other purposes. I understand that a primary means of communication between the Club and its members is via email and agree to receive emails from the Club. No information will be shared outside the Club, without your permission.

## Photo and Video

While not a regular occurrence, I understand that from time to time photos and videos may be taken during on court play and social gatherings. Use of media images will be limited to instructional, marketing, and social media purposes. I understand that I may request in writing that my image is not to be used.

## **GVR Court Cleanings Pilot**

GVR has been conducting a pilot for the court washings the last couple of weeks. If the pilot proves successful, then the Club schedules will be minimally impacted, as opposed to the previous schedule. GVR is trying to reduce impact on play for pickleball, tennis, volleyball, and Bocce ball.

KJB PBC: Wednesdays, 5am - 7am Canoa Ranch: Wednesdays, 5am - 7am East Center: Mondays, 5am - 7am

These mandatory court cleanings are being provided by GVR, which include blowing the dirt and debris from the courts and corridors. We must allow the GVR personnel to conduct and complete these cleanings as quickly as possible, without any interruptions. The sooner the cleaning is done, the sooner play may resume on the courts. Thank you in advance for your cooperation.

## **GVR Reciprocal Play Policy**

GVR has received questions about use of its sports courts by those who are not GVR members. To clarify, there are three options for non-club members to participate. In particular, GVR is rolling out the GVR Club Reciprocal Agreement which will be required by all clubs beginning October 1, 2022.

Three options for non-club members to participate:

## 1. GVR Club - Reciprocal Agreement

In the event the Club wishes to participate in this activity with an outside group, the GVR Club Reciprocal Agreement to request League Play has been updated.

- 1. League Play needs to be scheduled during non-peak hours, so it does not displace members.
- 2. Confirm proposed dates/times with Club Liaison.
- 3. Once confirmed, itemize the dates of play for both groups and obtain signatures by both groups.
- 4. Send .pdf of agreement via email or drop off a printed copy for the GVR Club Liaison at the Admin Office for approval by GVR

#### 2. GVR Club - Tournament Play

If a club has a one-time tournament in mind, GVR allows clubs to host competitive events and allow non-GVR members or guests to participate, with advance notice to the GVR Club Liaison for approval by GVR. See GVR CPM for further details.

The non-GVR members will be required to sign-in using the non-GVR Member Waiver of Liability.

3. Guest visiting a GVR member at the member-owned GVR property as defined in the GVR CPM

OUTREACH - GVR Foundation's first annual Neighbors Helping GVR Neighbors club challenge will kick off on November 1 through December 31. This challenge will be with other GVR clubs to help raise money for GVR neighbors in need of MAP (Member Assistance Program) funding to pay their annual dues.

In 2022, over 1,100 GVR neighbors are living on less than \$1500/per month. Monthly budgeting can be challenging for those with limited funds.

#### Player Development Committee - Carol Hammerle, Chair

Summer Player Development Program was a tremendous success running from June-October 1, 2022. Three skills levels were provided 2.5-3.0, 3.0-3.5 and 3.5/4.0. The original intent was to utilize just 4 courts but it became necessary to expand two skill levels to 6 courts by the end of July. The 3.5/4.0 skill level only needed 4 courts but both other skill levels required 6 courts. Just a FYI, the last session of the 3.0-3.5 skill level had 31 participants.

Developing Skills-After much discussion, coaches decided they did not want to incorporate the ratings tests for 2.0 or 2.5 as a part of the Developing Skills Program. They felt teaching individuals how to play and enjoy the game was more important than individual ratings. In all honesty, there is validity to providing players just the sheer enjoyment of the game versus the pressure of developing your game so you can test and move up.

Player Development for 4.0-4.5 players-I have been in contact with Wayne Kerr and Steve Reynolds with the intent of creating a player development program for 4.0 players to become 4.5. This is an aspect of the club that has been long overdue. Wayne has indicated his desire to start instruction with 4.0 women and men beginning December 16, 2022. The program would require 4 courts for instruction and a designated time for RR play. Initial plans are to provide the instruction on Fridays or Saturdays with a 12 or later start.

For 2023 Summer Player Development Program will plan on utilizing 6 courts for the 2.5-3.0 and 3.0-3.5 skill level. Also, Marilyn Rambo will be running the 2.5-3.0 program with the intent of having players culminate with the Ratings Test. The other 2 skill levels will continue to work on skills, strategies and some introduction to the ratings skill test and ghost doubles.

Developing Skills-Coaches agreed unanimously to allow only 1.0-2.0 skill levels so Pickleball Plus sign ups will restrict 2.5 players from participating in the program. PB 101 coaches will indicate to their students going into DS they are 2.0 skill level and will provide participant numbers to DS coaches the end of each class session. This will assist the DS coaches in how many participants they need to move to create sufficient space.

Starting October 4, Tuesday, the fall schedule for DS will be Tuesday/Thursday

from 1:00-2:30 PM. Please note because of SNAP class on Tuesdays utilizing 6 ball hoppers for the class, 8 additional ball hoppers have been added to the storage shelter so additional balls will be needed.

#### Pickleball.Plus & Scheduling - Dean Beilke, Chair

Implemented the CR, EC and PC 10/1 court schedules. Spent time on remote support of PC office display computers. Supported schedule changes required with Lobster repairs as well as problems with the EC and PC electronic locks.

The committee running the USA Pickleball Generous Wealth Advisors Pickleball Tournament to be held December 9-11 has decided to add a non-sanctioned tournament called the Foundation Games. Results of a survey said that we had players in our area interested in playing in a sanctioned tournament. We also found a significant number who preferred the non-sanctioned option. We decided to offer both, to give the greatest number of players the opportunity to participate in a competitive event prior to the start of the winter season.

The sanctioned tournament uses UTPR ratings and the non-sanctioned WPR rating systems to place players in brackets. Please realize that these ratings are based strictly on the results of tournament play and may differ from your club rating. Players can always choose to play up in skill and down in age. If partners fall into different skill/age divisions, you will play at the skill level of the highest partner and the age level of the youngest.
